

COMPLIANCE JUDGE

The Compliance Judge will judge the following in the Review & Inspection –

- **Calipers at the completion of the Review & Inspection**

The Compliance Judge will judge the following in the Quickstep/Compliments/Movements (Q/C/M) -

- **Recording Incorrect Uniform**
- **The Leader for having any part of the correct foot on the Disc for each movement for each Grade.**
- **The Leader to finish in the centre of the circle**
- **Dignity/Modesty/Cleanliness throughout**
- **Whistle signals (required to be used throughout the technical drill, excluding Masters grade)**
- **Any other compliance requirements delegated accordingly**

Judging of stipulated disc criteria will commence on completion of the whistle signal into each movement, or in the case of the Masters Grade teams who choose not to have whistles, with the arrival of the correct foot onto the Disc for each movement after completion of the Quickstep/Compliments phase and conclude with the arrival of the correct foot onto the Disc for the final movement of each Grades Quickstep/Compliments.

Caliper Check: (Spacing)

The Judges track for the Caliper check will be as follows: -

Under 13, Under 18, Senior - Leader-2, 2-1, 1-4, 4-7, 7-8, 8-9, 9-6, 6-3, 3-2, 2-5, 5-8, 4-5, 5-6. One point per **incorrect** spacing will be **deducted**.

A tolerance of 2.5cms either side of the correct measurement (in all grades) shall be permitted. The judging of spacing will be determined by the distance between identical positions of the same foot of adjacent marchers (e.g. the back of the heel).

Dignity/Modesty/Cleanliness

Will be judged as detailed in the Policy & Operations Manual (Technical) Section 11.

Standing Position

The Compliance Judge will judge the team at the Q/C/M phase **in a standing position behind the Display 1 Judge** at the **front** of the field. The placement shall be approximately **3** metres from the **front** boundary on an elevated platform of a minimum of 0.3 metres above ground level. (Please refer to the MNZ Guidelines for Elevated Platforms).

General

1. A **deduction** will be given when the discs are not achieved. When this occurs, the Judge will **circle** the **number in the deduction** box for that disc.
2. A **deduction will be given when the whistle is not blown in the Under 13, Under 18 and Senior grade. When this occurs, the Judge will circle the number in the deduction box for that Disc.**
3. It is not a requirement for the Compliance Judge to know the correct number of paces between each movement/phase, only that any part of the correct foot is on the disc on the completion of the whistle signal.
4. It is useful for the Compliance Judge to know how each movement commences for the Leader, ie; if there is an extra pace taken after the whistle signal.

- 5.** The Compliance Judge will be required to know where the Leader is positioned within the team for the 'march to' phase of each movement/phase for each grade.
- 6.** The Compliance Judge will be required to know where the disc for each movement is located on the field for each grade.
- 7.** The Compliance Judge is required to know that the colour of the discs are:
 - Master Grade – Blue
 - Senior Grade – White
 - Under 18 Grade – Red
 - Under 13 Grade – Yellow
 - Introductory Grade – Hot Pink
- 8.** The Compliance Judge will be required to perform additional compliance aspects which will be determined by the Director of Judging based on the R & I and Q/C/M released for the season.
