At the conclusion of Coach/Judge interviews, a copy of the Contest Draw for the Championship March, Plate March and Bowl March (if applicable) will be available from the Technical Manager and will be emailed to the Team address provided on their entry form. The Team's placing from the Qualifying March will determine allocation into the Championship March, Plate March or Bowl March (if applicable). (Rule of Participation NZC3.4)

Timetable for the Championships and the Qualifying March Draw will be emailed to the Team & Officiating Judges as soon as possible after the close of entries on the 31<sup>st</sup> January 2025 and will also be available from the MNZ Website.
